6. PAY OFFER UPDATE

- a. The pay offer is 2% in 2018 and 2% in 2019 for the majority with a few people at the bottom of the scale getting up to 3.54%
- b. In 2019 the NJC scale will be reviewed
- c. A briefing will take place in January followed by a recommendation and then a member ballot
- d. If the recommendation is to reject then we have work to do to persuade members that the cause is just and worth losing pay
- e. Strict criteria should be drawn up for hardship claims in the event of strike action
- f. Lower paid members may be put off filling in the form
- g. There should be a panel of at least 3 and separate branch committee members to offer advocacy and support for form filling
